- Encourage conservation of natural resources, recycling, source reduction and pollution control to maintain cleaner air, water and soil and to reduce landfill wastes. We share environmental best practices across the company.
- Apply development and manufacturing processes that do not adversely affect the environment.  
This includes improving operations and supporting the development of technologies that minimize waste, prevent air, water and land pollution, minimize health and safety risks for our employees and recyclers, and dispose of waste safely and responsibly.
- Introduce products, systems and services in the company's markets that are safe for their intended use, efficient in the use of energy, protective of the environment, and that can be reused, recycled or disposed of safely.
- Comply with applicable legislation and regulations, company standards, approved codes of conduct and good practices.
- Strive to continually improve the company's environmental management system and performance.

We value the company's security, both physical and digital. Therefore, we are committed to

- Assure the physical safety of persons (employees and visitors).
- Assure the safety, security and protection of data and property, including buildings, equipment and other assets.
- Work according to Security standards (e.g. CTPAT, AEO, ISO27001) and implement the necessary procedures and installations.
- Implement procedures and awareness programs with regards to business continuity planning, loss prevention and fraud prevention (e.g. business continuity plan, standards @ work).

To achieve these objectives, we have appointed a Management Representative and a team of EHS<sup>2</sup> officers, and we will provide the necessary time and means for the organization.

We expect that Environment, Health & Safety and Security are a constant concern of all employees, suppliers and contractors. All employees should make suggestions and propose improvements.


